

## Local Candidate Contract Addendum

The **Miss Clayland Scholarship Program** Board of Directors will work to prepare Miss Clayland 2020 to compete for Miss Ohio Scholarship Program in June of 2020. If during that preparation, the candidate requires the services of another consultant, the **Miss Clayland Scholarship Program** Board of Directors MUST be informed of the decision. This will allow the consultant to work as a team with the **Miss Clayland Scholarship Program** Board of Directors.

Local Directors must not recruit Local winners of other local programs for the purpose of offering competition preparation consulting services. Candidates with unresolved competition preparation consulting needs should contact the State Director for mediation.

**Miss Clayland Scholarship Program** will be held on October 12, 2019, at the Claymont High School Auditorium in Uhrichsville, Ohio., at the Claymont High School Auditorium in Uhrichsville, Ohio.

Entrant will forfeit any rights to compete if she arrives later than 9:00 am on Saturday, October 12, 2019 for rehearsal.

The **Miss Clayland Scholarship Program** Board of Directors will accept the first 12 completed applications received as their candidates for the pageant. Those received following the initial 12 will be kept on a waiting list in the order they were received as complete applications.

**Miss Clayland 2020** will be an ambassador for Tuscarawas County. She agrees to honor all reasonable personal appearance requests of the **Miss Clayland Scholarship Program** Board of Directors. The minimum number of appearances required will be four (4), with additional appearances possible depending on the distance required to travel. The **Miss Clayland Scholarship Program** Board of Directors will work with the winner's school and work schedule for appearances.

Candidates will be considered an official entrant upon receipt of the signed Candidate Contract (or proof that it has been submitted to the MOSP Office), Candidate Application, Candidate Contract Addendum (this includes proof of eligibility to compete and copy of birth certificate), Candidate Platform Sheet, Candidate Fact Sheet for Judges Interview, Consent and Vital Information Sheet, talent introduction, talent mp3 and photograph.

The 2020 Clayland candidates must apply for their scholarships by October 12, 2020.

I certify that, under the rules and regulations set forth in this contract, I meet and will maintain the requirements to become a candidate in the **Miss Clayland Scholarship Program**. I also realize that my entry will not be official until the Executive Director notifies me that all of the required forms and photograph are received.
